

REGISTRATION INFORMATION

Mini sessions will be held at every Thursday evening at the SNS Indoor Facility at 210 Thomas Raddall Drive. **The start and end date have not yet been confirmed, this will rely heavily on the opening date of the new SNS Indoor Facility.** This program has a **limited capacity**. If the program fills up, we may have to run sessions at a different location, day and/or time.

Game days and dates for players in the **U10 Academy, U12 to U18** age levels are not determined by HDSC. The game schedules are determined by the **NSSL** for the **Tier 1 league** and the **MISL** for the **Tier 2 league and U10 Advanced league**. Once game days/dates have been determined we will set a practice schedule to coincide with the individual team schedules and forward to all registered players. With several indoor facilities in full swing, there will be travel throughout the province for all Tier 1 teams.

All registered youth players must attend evaluation sessions at the Mainland Common Artificial Turf at 210 Thomas Raddall Drive. The schedule is posted on our website. There will be a fee of \$15.00 for these sessions. Please check the HDSC website for age specific times.

A jersey deposit is required for each registration for all youth players including U10 Academy. The cheques for \$60.00 should be dated for April 15th, 2012.

Players trying out for our competitive teams will need to include a post dated cheques along with the base fee.

For U10 Academy (Advanced and Intermediate) players would submit the base fee of \$170.00 and also submit a cheque dated for November 15th for an additional \$205.00 to total \$375.00.

For U12A or U12B players would submit the base fee of \$310.00 and also submit a cheque dated for November 15th for an additional \$65.00 to total \$375.00

For U14 and U16 Tier 2A players would submit the base fee of \$310.00 and also submit a cheque dated November 15th for an additional \$20.00 to total \$330.00

For U14-U16 and U18 Tier 1 players would submit the base fee of \$330.00 and also submit a cheque dated for November 15th for an additional \$95.00 to total \$425.00

Halifax Dunbrack will be offering a **U8 Academy program** this winter. This program is designed for players that want an enhanced training program and will consist of one game and one practice each week. Practices will be run by qualified technical trainers. Games will be against U8 Academies from other Metro area club. All players are welcome to register and participate in this program.

Fees may be broken into 3 equal payments. Cheques should be dated September 20th, October 15th and November 15th. All winter fees must be paid to HDSC by November 15th **Note:** HDSC Winter Registration fees are based on the previous year's winter costs. Should league fees increase, HDSC may increase the registration fee. All fees from previous season **MUST** be paid prior to the start of the current season.

We base the entry of teams in a league on the number of players registered. Therefore if you are interested in playing winter soccer at a certain age level early registration is encouraged. This way we know how many are interested in each age category.
